Pursuant to subsection 6(2) of the *Motor Vehicle Dealers Act*, 2002 (the "MVDA"), Wayne Walker ("Walker") and the Registrar, *Motor Vehicle Dealers Act*, 2002, ("the Registrar"), in accordance with section 4.1 of the Statutory Powers Procedure Act, do hereby waive the requirements of a hearing and consent to an Order of the Licence Appeal Tribunal based upon the following terms and conditions:

- 1. Upon obtaining the Registrar's approval of a sponsoring dealer, Walker will be registered as a motor vehicle salesperson subject to the requirements outlined in the MVDA and the terms and conditions contained herein.
- 2. Walker shall comply with all requirements of the MVDA and Ontario Regulation 333/08, the Code of Ethics in Ontario Regulation 332/08. Walker further agrees to read all correspondence and bulletins from OMVIC, including all OMVIC guidelines, as released.
- 3. Walker will not trade with any person acting as a motor vehicle dealer without first confirming that the person is registered as a motor vehicle dealer in accordance with the MVDA.
- 4. Walker acknowledges that "trade" refers to buying, selling, leasing, advertising or exchanging an interest in a motor vehicle or negotiating or inducing or attempting to induce the buying, selling, leasing or exchanging of an interest in a motor vehicle as defined in the MVDA and pursuant to section 36 through to and including section 51 of Ontario Regulation 333/08; and is not limited to the signing of contract. Walker further acknowledges that this includes attendance at auction on behalf of a sponsoring dealer and being employed or retained in positions commonly referred to as Sales Manager, Finance and Insurance Manager, Branch Manager, Business Manager, General Manager or any position which has supervisory authority over salespersons.

- 5. Walker shall only be registered as a salesperson for a registered dealer with the approval of the Registrar, and such approval shall not be unreasonably withheld.
- 6. Walker shall not be employed by a registered dealer which employs, retains and/or has as its agent in any capacity, Tatiana Walker.
- 7. Walker shall not be the final signatory on any sales or lease contracts on behalf of his sponsoring dealer.
- 8. Walker's employment as a salesperson shall not be transferred to another registered dealer unless that transfer is approved beforehand by the Registrar and such approval shall not be unreasonably withheld.
- 9. Walker shall ensure that his sponsoring dealer is informed of the Terms and Conditions contained in this document and shall provide the Registrar with proof of this within five (5) days of the transfer. If Walker's registration is transferred to another, or additional, sponsoring dealer, he shall ensure that the new sponsoring dealer is informed of the Terms and Conditions contained in this document, and shall provide the Registrar with proof thereof within five (5) days of the transfer.

- 10. Walker acknowledges that the Registrar may take further administrative action, including a proposal to suspend or revoke registration, arising from any matters that have occurred or may occur related to honesty and integrity, financial responsibility or compliance with these terms and conditions.
- 11. The conditions contained in this document shall be in force for a period of two (2) years from the date of the Order of the Licence Appeal Tribunal.
