A hearing took place on January 9 and 10, 2012 before the Licence Appeal Tribunal (the "Tribunal") arising out of a Notice of Proposal issued by the Registrar, *Motor Vehicle Dealers Act 2002* (the "Act") to revoke the registrations of M&M Fine Auto Ltd. and Massoud Yousof as a motor vehicle dealer and salesperson respectively.
