

SCHEDULE "A" – CONDITIONS OF REGISTRATION

PREAMBLE

Pursuant to Section 8(2) and 9 of the *Motor Vehicle Dealers Act* ("MVDA"), the Registrar proposes the following conditions on Sheik Omar Alli (the "Applicant"):

GENERAL

1. The Applicant will comply with all requirements of the MVDA and Ontario Regulation 333/08, the *Code of Ethics* in Ontario Regulation 332/08, the Ontario Motor Vehicle Industry Council ("OMVIC") Standards of Business Practice, 2010 and OMVIC Guidelines, as may be amended from time to time. The Applicant further agrees to read all correspondence and bulletins from OMVIC as released.
2. The Applicant will provide the sponsoring Dealer with notice in writing of any findings of guilt, convictions and pending charges in the future. The Applicant will provide the Registrar with a copy of the notification acknowledged by the signature of the sponsoring Dealer.
3. The Applicant will provide the Registrar with full and complete disclosure in all future correspondence and on all future applications, regardless of whether or not disclosure has been made previously to the Registrar.
4. The Applicant confirms that the particulars and circumstances of the findings of guilt, convictions and pending charges are substantially as disclosed to the Registrar.
5. The Applicant will not drive a motor vehicle without a valid driver's license.
6. The Applicant will not apply to be a Dealer.
7. The Applicant will not be involved in the process of trading in motor vehicles without the benefit of registration and agrees to be involved in the process of trading motor vehicles only for the dealer to whom he is registered.
8. The Applicant will not transfer his registration to another Registrant without first obtaining prior written consent of the Registrar.
9. The Applicant agrees that he will not to work for 1207036 ONTARIO LIMITED o/a MOTOR CITY AUTO SALES/THE APPROVAL STORE for a period of four (4) years or 2 renewal cycles from the date of signing of the original terms and conditions.

ACKNOWLEDGMENT AND UNDERTAKING:

- 10. The Registrar is relying on the accuracy and completeness of all documents, statements or information provided by the Applicant in support of the Applicant's application for registration.

- 11. The documents, information or statements provided to the Registrar are true to the best of the Applicant's knowledge, and belief; and that full answer to all questions, inquiries and requests made by the Registrar in connection with the Applicant's application have been given.

- 12. The Registrar may take further administrative action, including a proposal to suspend or revoke registration, arising from any matters that have occurred or may occur related to honesty and integrity, financial responsibility or compliance with these terms and conditions.

- 13. Independent legal advice has been obtained or the Applicant has had the opportunity to obtain independent legal advice respecting consent to the Terms and Conditions contained in this document.
